CROW'S FEET

Description

The delicate skin around the eyes is extremely thin and is especially vulnerable. That is why signs of aging will emerge first in this area of the face. Crow's feet are a typical example of skin aging around the eyes.

Remescar Crow's Feet is an instant and effective cream which helps to reduce and diminish the appearance of crow's feet with just one single application per day.

Its revolutionary technology eWRINK immediately targets and tightens skin structures around the eyes, by using a unique combination of plant silicones, clay minerals, phyto-saccharides and concentrated glucoside particles which will fill in wrinkles and rejuvenate the skin.

Intended use

Remescar Crow's Feet is specially formulated to address crow's feet around the delicate eye area.

Instructions for use



Step 1: Wash your face gently and pat dry.



Step 2: If you are using a moisturizer (day cream or eye cream), always allow time for your moisturizer to be fully absorbed before applying Remescar Crow's Feet.

Step 3: Squeeze out a small amount of Remescar Crow's Feet on your fingertip. You should aim for the size of a grain of rice; any less will not be enough, and any more is generally too much and won't fully absorb into the skin or could cause sensitivity.



Step 4: Rub the cream between your 2 index fingers until the cream becomes colorless (5 to 10 seconds). Make sure there is still enough cream between the fingers. In case it doesn't feel wet anymore, take a small amount on your fingertip again. This is one of the key factors to make Remescar Crow's Feet work correctly.



Step 5: Gently apply the cream with one finger, on the area where crow's feet are. Blend in using a light gentle tapping motion until the cream completely absorbs into the skin. You should avoid using the cream too close to your eye because the product will spread when it warms up with your body temperature.



Step 6: Remain expressionless for 2-3 minutes while the product dries to achieve dramatic results (fanning will accelerate the process). Simply tissue off the excess of cream with a bit of water if too much cream is applied. Wash hands and close the tube after use.

To Remove: Cleanse applied area with water and pat dry.

For under makeup: First, apply your usual products (eye serum, daily moisturizer, etc.) and allow enough time for these products to penetrate the layers of your skin (a minute or two). Then you can apply a very thin layer of Remescar Crow's Feet to the targeted area as instructed above. If you see a white residue you have either used too much product or did not use moisturizer. Simply tissue off the white residue with a bit of water. Once the product has dried, apply your makeup as usual.

Note: Oil-based makeup may reduce the effectiveness of Remescar Crow's Feet.

Do you also suffer from eye bags & dark circles? Try Remescar Eye Bags & Dark Circles, an instant and effective cream which helps to diminish eye bags and the appearance of dark circles in just a few minutes.

Make sure to not use Remescar Crow's Feet with Remescar Eye Bags & Dark Circles on the same skin area, as this could give some white residue or cause sensitivity.

Precautions

- Keep out of reach of children.
- Must only be used as directed.
- For external use only.
- Avoid contact with mucous membranes or the eyes. Rinse thoroughly with water in the event of contact with the eyes.
- Avoid excessive sun exposure.
- Discontinue use if irritation or sensitization (redness, pain, etc.) occurs. If skin irritation or sensitization occurs, discontinue use and consult your physician if the symptoms persist for more than 48h.
- Use of the product is inadvisable if you have allergic reactions to one of the ingredients.
- Do not use on damaged skin (e.g. open or infected wounds, third degree burns, acne, eczema). Only use on normal healthy, non-infected skin.
- Only use once a day.
- Do not use the product continuously for more than 4 weeks.
- To ensure optimal performance and to avoid dependence on the product, it is advised to allow the skin to rest a few days (4-5) after using the product daily for 4 weeks. In case of occasional use of the product there is no need for a resting period.
- Do not use if the packaging has been damaged.
- Not recommended for pregnant or breastfeeding women.
- Not recommended for children under the age of 16.
- Once opened, it's advised to use the product within 12 months.
- It's advisable to store the product in a cool dry place below 30°C.
